FBD Sorting Guidelines

It is important we provide high quality food to the agencies of the food bank. Please inspect all items using the following guidelines.

CANS

1 year past expiration date

Throw away cans exhibit the following:

- Dents on the seam of the can (different than the seam of the wrapper)
- Dents producing sharp edges
- Tomato or Pineapple products with any significant dent
- Bulges to the top or bottom of the can
- Rest which cannot be wiped off

DRY GOODS

6 months past expiration date

If the product is exposed in any way, throw it out.

If the product is in two separate containers (such as cereal), check the inner seal before disposing. If inner seal is in tact, the product is salvageable.

GLASS JARS

1 year past expiration date

Check the pop-top; if seal is broken, throw away.

PLASTIC JARS

1 year past expiration date

Check seal; similar to glass jars

- ▶ Products with stained labels should be discarded.
- ▶ Many items will not have dates. In this case, look at the item (label and condition) and ask yourself, “ Would I eat an item from this container?”
