Applicants must:

1. Be 18 years of age or older.
2. Have reading and math skills at an 8th grade level.
3. Not be a danger to self or others.
4. Be available to be in class from 9:00am to 4:00pm Monday through Friday.
5. Be available for any special catering events that Food Bank hosts.
6. Be curious, ready to learn, and willing to do homework.
7. Be interested in, and have a desire to work in the food service industry.
8. Be able to read, speak, and comprehend English in a fast paced environment.
9. Have basic math skills and an adequate reading level for studying a textbook, completing exams, and writing job related documents.
10. Have a strong desire to progress in a food service career.
11. Able to lift 40 pounds and stand up to 6-8 hours daily with or without a reasonable accommodation.
12. Be able to see well enough to read at 2.5 feet with or without reasonable accommodations.
13. Able to attend class every day on time.
14. No violent or sexual criminal history. (This means murder, or on sex offenders list)
15. You must pass a drug test, and participate in random tests.
